Annual General Meeting (AGM) on December 17, 2023

In accordance with the "Reasons for Decision" document from the Divisional Court dated November 3, 2023 (attached), the Vietnamese Association, Toronto (VAT) will hold its Annual General Meeting (AGM) with the following details:

1. Date and Time: 2:00 PM on Sunday, December 17, 2023 (to avoid holiday season and proximity to the TET Festival on January 27, 2024).
2. Format: Virtual via Zoom.
3. Members from the years 2019 to the present may attend the AGM (other than those who have resigned their membership, died, or have been expelled). Please email us to prepare the membership list for quorum count before 5:00 PM on November 25, 2023. VAT will send voting ballots, proxy forms, and Zoom connection details to you.
4. If you wish to maintain your membership status and have not paid the annual fee for 2023 (\$10 for singles or \$15 for a family of two), please make a cheque payable to "Vietnamese Association, Toronto". You can send it to either of the following addresses: "1364 Dundas St. West, Toronto, ON M6J 1Y2" or "3585 Keele St., Unit 13, North York, ON M3J 3H5." For convenience, you can also pay the fee through e-transfer to vat@vatoronto.ca. Membership fees must be received by 5:00 PM on November 25, 2023, to prepare the membership list for quorum count. You can send an email, mail, or visit the VAT offices to make the payment before 5:00 PM on November 25, 2023.
5. If you wish to join as a new member to participate in the AGM on December 17, 2023, please obtain the application form from the VAT offices (address provided above) or request it via email at vat@vatoronto.ca. Applications must be received by 5:00 PM on November 25, 2023.
6. If you wish to run for the Board of Directors at the AGM on December 17, 2023, please obtain the application form from the VAT offices (address provided above) or request it via email at vat@vatoronto.ca. The application must have two nominators: the first nominator must be a member of the Board of Directors or Advisory Board, and the second nominator must be a regular member of the association. The application must be submitted to the VAT offices or emailed to vat@vatoronto.ca by 5:00 PM on November 25, 2023.
